

Please accept the following information and request on behalf of the City of Franklin Fire Department to allow us to trade in our old Hydraulic Extrication Tools to replace them with Newer Model Extrication Equipment as outline in the attached quote.

In 2012 and 2013 we were able to train 17 Personnel in the most modern extrication practices via the District 5 Machinery/Vehicle Extrication Technician Class. While in class we trained with the most modern tools and we learned that our current equipment was obsolete, no longer assured access to new modern car technology, and beyond our new extrication techniques.

While investigating pricing and replacement we were offered the opportunity to trade in our old equipment. This allows us to make significant savings to this project from the trade in. If we kept this old equipment it will quickly loss value, be a constant burden financially and with the burden of maintaining the equipment. We would also have to find ways to house the equipment with no room on any apparatus for this project.

The cost savings from this trade is significant and far out ways any benefit to keeping the old equipment. With this letter we present pictures of the old equipment we would like to deem access and remove from service. Then ask for your permission to allow us to trade them in for the replacements per the quote as mentioned.

The total savings with trade in would be \$3,475.00 with the purchase from Five Alarm Fire Equipment. The total price for new extrication tools would be \$23,000.00.





The following terms and conditions shall apply unless and except to the extent Hurst Laws of Life may specifically agree otherwise in a written contract or agreement with Purchaser or specifically state otherwise in a written quotation issued to Purchaser.

Orders

Orders must contain the following information at a minimum: Purchaser Name; Address and Fax Number; Purchaser Contact Name, Email Address, & Telephone Number; Hurst Jaws of Life Part Number; Item Description; Item Quantity; Item Price; Requested Ship Date; Ship to Location; All pertinent logistics information to insure correct processing

If an order is submitted in response to a specific quotation or proposal issued by Hurst Jaws of Life, the quotation or proposal must be referenced in the order and state that it is submitted pursuant to such quotation or proposal.

All orders must satisfy any Hurst Jaws of Life minimum order requirements. Hurst Jaws of Life's normal minimum order is US\$100.

All orders are subject to acceptance by Hurst Jaws of Life, and Hurst Jaws of Life shall have no obligation under any order unless and until the same is accepted by Hurst Jaws of Life and a confirmation of acceptance has been issued to Purchaser. To be effective, a confirmation of acceptance must be given in writing or by fax, email or other electronic media.

Unless and except to the extent specifically stated otherwise in Hurst Jaws of Life's confirmation of acceptance, Hurst Jaws of Life's acceptance of an order shall always be upon and subject to these Terms and Conditions of Sale, and any different or additional terms and conditions set forth or referenced in Purchaser's order or otherwise are rejected and shall not apply.

Hurst Jaws of Life shall have the right to refuse to accept any order for any reason.

Price sheets and other literature are not offers to sell by Hurst Jaws of Life.

Order Cancellations

All requests to cancel an order must be submitted to Hurst Jaws of Life in writing.

A request to delay or change shipment after an item has been scheduled for production or shipment may be treated as a cancellation.

Orders may be canceled only upon payment of cancellation charges as determined by Hurst Jaws of Life. Cancellation charges may include production cost, engineering expense, selling expense, a reasonable amount for overhead, and a reasonable amount for profit. If an order includes items to special specifications or sizes or of types not in general production, cancellation charges will include payment for all special work. A minimum 15% cancellation charge will be assessed on all order cancellations.

If, through no fault of Purchaser, the scheduled shipping date is missed by more than 30 days, no cancellation fee shall be assessed against Purchaser if the order is cancelled due to late shipment.

Shipping and Dimensions, Sizes and Weights

Scheduled shipping dates are approximate only and not guaranteed and are subject to timely receipt of all necessary information and documentation from Purchaser.

Unless and except to the extent an order expressly states on its face that no partial shipments are allowed and/or that no early shipments are allowed, Hurst shall have the right to make partial shipments and to make shipments prior to the scheduled ship date on the order confirmation.

Shipping terms for all orders are FCA (Incoterms 2010) Hurst Jaws of Life, 711 North Post Road Shelby, NC 28150 USA, unless otherwise specified in Hurst Jaws of Life's confirmation of acceptance of an order. Freight allowances will be considered only for orders with a net order value \$5,000 and over. Hurst Jaws of Life shall have the right to designate carrier and routing whenever freight is allowed. Where freight is not allowed, Purchaser's designated carriers will be used where practical; provided, however, that Hurst Jaws of Life has the right to designate other carriers and routing to the extent Hurst Jaws of Life deems necessary or appropriate. Where freight is not allowed, the freight charge will be prepaid and added to the invoice.

Prices include standard packaging and packing only. Any export or other special packaging or packing requested by Purchaser shall result in additional charges.

Published dimensions, sizes and weights are approximate only and are not guaranteed. Certified dimension drawings of an item may be obtained from Hurst Jaws of Life at US\$25 per set.

A flat handling fee of US\$50 will be charged on orders \$5,000 and above or with freight allowances.

Hurst Jaws of Life shall have the right to refuse to ship items to any person or entity or any destination or for any use that it believes to be unlawful.

Pricing and Payment Terms

All orders shall be Cash-in-Advance, Pre-Pay unless other credit terms are established in writing with Hurst Jaws of Life. Unless specifically stated otherwise in a written quotation, proposal or Special Pricing Notification (SPN) authorized on behalf of Hurst Jaws of Life.

All prices shall be based on Purchaser's standard discount (if any) and Hurst Jaws of Life's published price list in effect on the date the order is placed

The standard payment terms for the purchase price of items and other amounts payable by Purchaser shall be 1% 10, net 30 days from date of invoice

No order shall be accepted that reflects pricing that differs from Purchaser's standard discount (if any) or Hurst Jaws of Life's published price list in effect on the date the order is placed or payment terms that differ from 1% 10, net 30 days after invoice, unless accompanied by a copy of a duly signed written quotation, proposal or Special Pricing Notification (SPN) reflecting such different pricing or payment terms. Invoices may be issued at any time after shipment. Partial shipment may be invoiced as the partial shipments are made.

Interest at the rate of 1.5% per month may be charged on all overdue amounts.

If Purchaser's account with Hurst Jaws of Life or any other IDEX unit should become past due or, in the judgment of Hurst Jaws of Life, Purchaser's financial condition does not justify continuance of production or shipment on the applicable payment terms, Hurst Jaws of Life may, at its sole discretion, suspend production or shipment and require full or partial payment in advance of production or shipment.

In the event Hurst Jaws of Life has completed and prepared items for shipment and shipment is delayed by Purchaser for any reason, Hurst Jaws of Life may invoice Purchaser as if shipment had been made and the amount invoiced shall be due and payable as if shipment had been made. After invoice, items held by Hurst Jaws of Life as a result of a delay in shipment by Purchaser shall be held at the risk and expense of Purchaser.

Title and Risks

Hurst Jaws of Life will cease to have any responsibility for items and title and all risk of loss or damage to items shall pass to Purchaser in accordance with the applicable shipping term.

Purchaser should make a visual inspection of shipping containers and packages for obvious damage before "signing off" on the carrier's receipt. If damage is noted, it should be so indicated on the carrier's receipt before acceptance. Lack of damage to the outside of a shipping container or package does not guarantee undamaged contents. Purchaser should open shipping containers and packages and inspect contents promptly after receipt. If contents are damaged, Purchaser should contact the carrier immediately. If contents do not match the order, Purchaser must notify Hurst Jaws of Life immediately.

Any shortages or order differences reported to Hurst Jaws of Life more than 30 days after shipment or 10 days after receipt will not be eligible for return, replacement or adjustment by Hurst Jaws of Life.

Returns

Hurst Jaws of Life will only consider accepting returns of items shipped within the last 12 months. No returns shall be accepted by Hurst Jaws of Life unless accompanied by a Return Goods Authorization (RGA) issued by Hurst Jaws of Life. Hurst Jaws of Life shall have no obligation to issue an RGA. In order to be returnable, items must be new, unused, the same as items currently being offered for sale by Hurst Jaws of Life, and in their original packaging with all associated documents, such as warranty cards and user manuals. Items which are no longer available, discontinued, obsolete, or special order/production, or otherwise deemed not returnable will not be accepted for return. Hurst Jaws of Life reserves the sole right to determine the returnability of items. Items which are received in non-returnable condition will be handled in one of the following ways:

1. Destroyed with Purchaser's approval
2. Returned to Purchaser at its expense
3. Refurbished and returned to Purchaser at its expense with its approval
4. Partial credit issued to Purchaser at the sole discretion of Hurst Jaws of Life

Hurst Jaws of Life will have no responsibility or liability in connection with items returned without an RGA. Returns arriving without a RGA may be refused. All items returned must be properly packed and identified in accordance with the RGA.

All costs and expenses associated with returns shall be borne by Purchaser. Return costs and expenses may include labor, material, administrative, and any other costs and expenses arising out of the return. A minimum 20% restocking charge will be assessed on all returns. If credit is to be allowed on returned items, any credit will be subject to and conditioned the receipt of the returned items in new, unused, undamaged and saleable condition.

Hurst Jaws of Life may accept a return and waive the restocking or cancellation fee in the event Hurst Jaws of Life had made an error such as an incorrect part number or a duplicate order or other similar circumstance.

All returns are at Purchaser's sole risk and expense, and any shipping charges on returned items shall be paid by Purchaser. No collect shipments will be accepted unless authorized in writing in advance by Hurst Jaws of Life.

Designs, Materials, Components and Discontinuance

Hurst Jaws of Life may make changes and modifications to the design of any item at any time without affecting any order or making the same changes and modifications to any previously produced or sold item.

Items shown in catalogs, advertisements or other literature may vary from the actual items shipped in design, look or content. Hurst Jaws of Life may substitute materials, components and parts for any item at any time without affecting any order or making the same changes and modifications to any previously produced or sold item. Hurst Jaws of Life may discontinue the production and sale of any item at any time without incurring any liability or obligation in connection with any order or any previously produced or sold item.

Taxes

Purchaser shall pay all sales, use, value added and other taxes, all duties and tariffs, and all other amounts payable to any governmental authority, whether or not presently in effect, imposed upon or payable with respect to the manufacture, sale, transportation, possession, use or delivery of any item purchased by Purchaser, except that Purchaser shall not be required to pay any tax imposed upon or measured by the income of Hurst Jaws of Life. In the event Hurst Jaws of Life should be required to pay any such tax, duty or tariff, or other amount, Purchaser shall promptly reimburse Hurst Jaws of Life for such tax, duty or tariff, or other amount on demand.

Any claim by Purchaser that an order is not subject to tax, duty or tariff, or other amount payable to a governmental authority must be supported by any appropriate exemption certificate or other documentation acceptable to tax and custom authorities. Unless a current copy of an appropriate tax exemption certificate or other acceptable documentation is on file at Hurst Jaws of Life, all such documentation must be submitted to Hurst Jaws of Life with the order.

Installation, Operation and Maintenance

Hurst Jaws of Life's installation, operation, and maintenance instructions assume the existence of normal factors and conditions and do not allow for any special factors or conditions that may exist during actual use. Purchaser shall be responsible for ensuring that only properly trained and qualified personnel install, operate and maintain items products purchased from Hurst Jaws of Life.

Warranty

Hurst Hydraulic Products

(Hurst® Low Pressure Rescue Tools, Hurst® High Pressure Rescue Tools, eDRAULIC™ Rescue Tools, and Mini Lite™ Rescue Tools)

Hurst®, Hurst Jaws of Life®, eDRAULIC™ and Mini Lite™ rescue tools ("Tools") sold by Hurst are warranted by Hurst to be free from defects in material and workmanship for a period of 2 years from the date of shipment by Hurst ("Standard Warranty Period").

During the Standard Warranty Period, Hurst will repair or, at its option, replace at no charge any Tool or original or warranty replacement Tool part that Hurst determines to have failed during normal and proper use due to a defect in material or workmanship. Any repaired or replacement Tool or Tool part shall be warranted only for the remainder of the original Standard Warranty Period. If requested by Hurst, a Tool or Tool part that is claimed to be defective must be delivered to Hurst or an authorized Hurst dealer for inspection and evaluation. Any Tool or Tool part that is replaced shall be the sole property of Hurst and must be returned to Hurst upon request. Hurst shall have the right to use repaired and reconditioned Tools and Tool parts for warranty repairs and replacements.

This Standard Warranty protects only the original purchaser and does not apply to subsequent purchasers or to any Tools sold as "Used" or "Reconditioned", or any rescue tools other than Hurst®, Hurst Jaws of Life®, eDRAULIC™ and Mini Lite™ rescue tools.

This Standard Warranty is conditioned upon and subject to:

- Registration of the Tool with Hurst by the original purchaser, within 90 days after the date of original purchase from Hurst or an authorized Hurst dealer. Instructions for registration of the Tool with Hurst are included with the Tool and can also be obtained by contacting Hurst's Customer Service Department by telephone at (800)562-5041 or by email at contacthurst@idexcorp.com.
- Annual service of the Tool by an authorized Hurst dealer during the Standard Warranty Period.

This Standard Warranty does not apply to:

- Damage to a Tool or Tool part occurring during or after shipment (claims of damage during shipment should be presented to the carrier)
- Normal wear and tear and consumable Tool parts and items, including, but not limited to seal rings, plunger blocks, couplings, cutter blades, hoses and other rubber components, and fluids
- Any issue related or attributable to abnormal or improper use or mishandling of a Tool, including, but not limited to, use for a purpose other than extrication and rescue
- Any issue related or attributable to failure to follow and strictly adhere to maintenance and inspection instructions and guidelines contained in the Owner's Manual provided with a Tool or any maintenance or inspection bulletins or notices provided by Hurst
- Any issue related or attributable to failure to follow and strictly adhere to operating and use instructions and guidelines contained in the Owner's Manual provided with a Tool or any operating and use bulletins or notices provided by Hurst
- Any issue related or attributable to repair or installation of a Tool or Tool part by persons other than Hurst or an authorized Hurst distributor
- Any issue related or attributable to rusting or corrosion of a Tool or Tool part
- Any Tool or Tool part that is changed, altered or modified unless the change, alteration or modification is made by Hurst or strictly in accordance with Hurst's written directions and instructions
- Any issue with a Tool or Tool part related or attributable to failure or substandard performance of any other manufacturer's equipment, system, product, component or part

- Any accessories (including Mini Lite™ speed pumps), spare or non-warranty replacement parts, or other products that may be sold either with or separate from Tools (Any warranty with respect to such accessories, spare or replacement parts, and other products shall be limited to a pass through of the warranty (if any) furnished by the manufacturer of such items. For accessories and spare and non-warranty replacement parts manufactured by Hurst, see the Hurst®, Hurst Jaws of Life®, eDRAULIC™ and Mini Lite™ Rescue Tool Accessories and Parts Warranty.)

Unless and except to the extent mandated otherwise by law, under no circumstances shall Hurst have (i) any liability or obligation to the original purchaser or any other person for any claim, loss, damage, injury, liability, obligation, cost or expense that directly or indirectly relates to or arises out of the use or failure of any Hurst®, Hurst Jaws of Life®, eDRAULIC™ or Mini Lite™ rescue tool, other than as expressly set forth in this limited lifetime warranty, or (ii) any liability in connection with any Hurst®, Hurst Jaws of Life®, eDRAULIC™ or Mini Lite™ rescue tool for indirect, special, punitive or consequential damages, including, but not limited to, loss of sales, loss of profits, down time, loss of production, loss of contracts, or damage to reputation or good will, whether or not Hurst was aware of or advised of the possibility of such damages.

Vetter® 3 years for lifting bags; 2 years for non-industrial products and 1 year for industrial products

During the applicable warranty period, Hurst will repair or, at Hurst's sole option, replace a defective product without charge. Any repaired or replacement product shall be warranted only for the remainder of the original warranty period.

Any item that is replaced shall be the sole property of Hurst and be returned to it upon request.

The above warranty does not cover:





FFD Extrication Equipment 2013

The Current extrication equipment on two of the first out FFD apparatus are inadequate due to new car construction as well as the service life of some pieces of equipment on all apparatus. When talking about the newer construction the manufacturers of vehicles are using UHSS(Ultra High Strength Steel) and Boron for the structure of the many vehicles. This type of construction is relatively new, but has been used in some vehicles since 2001 in the U.S. These materials and construction types are predicted to be in %33 of all vehicles produced by the year 2020, based on a 2011 article. This article Titled "Assessment of Powered Rescue Tool Capabilities with High-Strength Alloys and Composite Materials" (NFPA,2011) provides an excellent resource on information on this subject. What we have found is that some of our current equipment is rated at less than half of what is required to deal with this type of technology. A link to this article and a couple other resources are included at the bottom. An example of the commonness of such construction is employed in all 2009 and up Ford F-150's.

We have also expanded the knowledge of many members of our department by sending them to classes in recent years to many members now holding the certification of "Vehicle and Machinery Extrication Technicians". This has been beneficial to our department in that we now have a higher level of expertise in this subject, which will ultimately provide better care. Having this knowledge has made us better aware of the limitations of our current equipment, as well as equipment that would better suit us. Also this will bring uniformity to our response of having the required equipment at every type of motor vehicle accident.


Motor Vehicle Accident with Entrapment

I65 Single Car Rollover Accident

On the morning of July 7th a serious car accident with multiple patients took place on I65. Engine 21 was first unit to arrive on scene as they were covering Engine 22 who was already on a call. They attempted a cutting maneuver to free one of the patients involved in the accident. The tool was unsuccessful and the patient rescue was delayed as the crews had to adjust their tactic.

Two potential causes for this problem have been identified, the limitations of the tool and the age of the pump. The tool is not rated to the modern car technology, as well as the pump is over 12 years of age and in need of replacement.

Once the victim was removed the patient was then carried through tall grass and up a slight incline until they reached the pavement. It was felt that a rope rescue could have been completed to assist carrying the patient. However, we do not have sufficient rope tools, and all of them are in need of replacement. All Life Safety Rope needs to be replaced within seven years of service. We cannot perform these maneuvers without updated equipment.
