WHEREAS, the City of Franklin by and through its Franklin Board of Public Works and Safety and Johnson County, Indiana, by and through its Board of Commissioners have agreed to cooperate in obtaining a Downtown Parking Study of Franklin, Indiana;

WHEREAS, such agreement is memorialized in the Interlocal Agreement attached as Exhibit "A", and

WHEREAS, pursuant to Indiana Code §36-1-7 *et seq.*, the Common Council of the City of Franklin is in favor of the Interlocal Agreement.
