A Budgetary Ordinance
Authorizing An Additional Appropriation

WHEREAS, it has been determined that it is now necessary to appropriate more money into the General Fund-Fire Department and Police Department's 2014 annual budget, and

WHEREAS, during the transition from paper submission to electronic submission to the Police and Fire Pension Division of INPRS (formerly known as PERF) in the last quarter of 2012, two employees with over 32 years of service were omitted as they are no longer required to contribute toward their pension after 32 years of continuous service, and

WHEREAS, the City of Franklin's contribution for both employees had been appropriated in the respective budget years of 2012 and 2013 but the funds were not transferred and,

WHEREAS, the city continues to have an obligation to contribute the Employer's share to INPRS for these employees, and

WHEREAS, the City of Franklin is obligated to fund the unpaid amounts from the last quarter of 2012 in the amount of \$2,856.49 times two and 2013 in the amount of \$10,609.82 times two,

NOW, THEREFORE, be it ordained by the Common Council of City of Franklin, Indiana that for the expenses of the taxing unit, the following additional sums of money are hereby appropriated for the purposes specified, subject to the laws governing the same:
