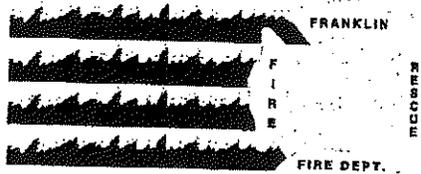

Please find enclosed invoice outlining repairs needed for Quint 23#.

On Friday Oct, 23rd a front leaf spring was found to be broken on Quint 23#. It was immediately taken out of service and sent to Anderson Spring for repairs.

On inspection additional deficiencies were found as outlined in the invoice.

We do not have the funds within our budget to cover these needed repairs.

In addition to the repairs noted a total of six tires need to be replaced on our apparatus. We intended to wait for the tire replacement until January 2016 when the funds would be available within our budget. Due to the rapid deterioration of these tires this must be done immediately.

The estimate of \$12,220 for Quint repairs, \$4,500 estimated for tire replacement we would request \$17,000 appropriation to fund these needed repairs.
