Planning and Engineering Remarks

There is currently no parking allowed on the east side of Knollwood Court from Fair Oaks Drive north to the dead end. This no parking zone should be extended south to Israel Lane on the east side only, primarily because the pavement width of 24 feet is not favorable to 2 sided parking. This would require the installation of one new post and one new no parking sign (that meets City and MUTCD standards) near the Knollwood Court/Israel Lane intersection.

The Street Department supports this request and has no other comments.

Police Department Remarks

It appears that the complainant has a valid complaint that is shared by the signatures on the petition and the Whiteland School bus garage. I am in favor of the no parking request but we would have to consider where the vehicles would relocate to and what problem it could cause. We have assigned a night shift supervisor to take photographs of the area and to monitor to see if it is a constant problem.

Fire Department Remarks

The Department is ok with the no parking. Anytime we can get cars off the street and into their driveways it is better for the fire trucks to get through the streets.
