



RE: Budget Ordinance 13-09 Additional Appropriation \$14,200 Fire Medic Fund - 200 series

The Franklin Police Department has applied for a bulletproof vest grant from the Federal Government which requires them to purchase bulletproof vests, pay up front and then apply for a reimbursement. During the 2013 budget process it was determined that this purchase should be made through the Fire Medic Fund rather than the Police Department budget in the General Fund.

The Fire Medic Fund 2013 approved appropriation in the 200 series for the vests is \$23,000. The purchase of new vests will require a total of \$37,200. Therefore we are requesting an additional appropriation of \$14,200 in the 200 series of the Fire Medic Fund. The current Fund balance is \$201,319.22.

Also, there is a 2013 appropriation in the 300 series of the Fire Medic Fund with a balance of \$1,984.96, which we believe sufficient to cover any unanticipated expenses in the fund that could arise during the remainder of 2013.
