**RESOLUTION NO.: 13-22
OF THE COMMON COUNCIL OF THE
CITY OF FRANKLIN, INDIANA**

**A RESOLUTION AUTHORIZING THE USE OF
CERTAIN CREDIT CARDS ACCOUNTS
(And Repealing Resolution No. 10-08)**

WHEREAS, the City of Franklin, Indiana ("City"), by its various department heads, needs the use of credit card services for the efficient operation of City functions;

WHEREAS, Horizon Bank ("Bank") has offered to provide credit card services to the City upon terms and conditions which are beneficial to the City;

WHEREAS, the former enabling Resolution is repealed in its entirety. The effect of this enactment and repeal is to change name of the Planning credit card to Planning & Engineering, change Engineering to Community Development and change Senior Center to Active Adult Center. Also, to delete the MS4 credit card and add an additional card to Waste Water Treatment.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, RESOLVES THE FOLLOWING:

Resolved: The below-referenced departments and elected officials are authorized to maintain and use the number of credit cards with corresponding credit limits as shown below. The Clerk-Treasurer is authorized to apply in the City's name to the Bank for such Visa and/or Mastercard Charge credit cards for commercial and business use by the City's officers and employees. Further, the City is authorized and empowered to pay all indebtedness incurred by the use of such credit cards, whether such use is authorized or unauthorized, including all indebtedness incurred under the prior Resolutions. Further, the Bank is authorized to rely upon this resolution until written notice of its revocation is delivered to the Bank and that the authority granted by this resolution will apply with equal force and effect to the successors in office to the officers herein named.
