### Summary:

- 1. On September 18, 2017, the Franklin Common Council passed Resolution Number 2017-11, approving a 5-year tax abatement on real property with a 2% Economic Development Fee at 1556 Amy Lane.
- 2. Actual and estimated benefits, as projected for 2018:

- 3. The company indicated they would hire 2 new employees on their SB-1. One employee was hired in 2018. The hourly salary is slightly higher than the estimate.
- 4. The company is on schedule for real property improvement estimate.
- 5. The tax abatement for Superior Systems & Supply is scheduled to expire in tax year 2023 payable 2024. The final compliance review will take place in 2024.

While it has always been the intention of Superior Systems & Supply, Inc. to complete construction in July 2018, as was estimated on the Form SB-1. Under-estimated building cost, financing considerations and lag times associated with construction, the building was not completed until November 2018.

Due to these untimely circumstances, the company has also only been able to employ 1 additional employee, as opposed to the 2 additional employees which were originally projected to be hired by this time.

Since we have our building completed and moved-in, we hope in the very near future to hire 1 additional employee. It is our desire and request that the City of Franklin will look favorably upon our activities and grant us an extension of time to be in full compliance with our tax abatement commitments.
