Failure to comply with these conditions within the time specified will entitle Owner to consider you in default, annul this Notice of Award, and declare your Bid security forfeited.

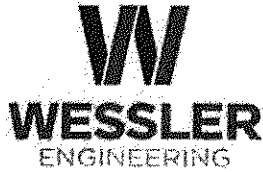

Pursuant to the Advertisement for Bidders, bids for the Chemical Phosphorus Removal and UV System Replacement were received at 2:00 p.m. on June 20, 2019 at City Hall and were opened and read aloud.

Four (4) bids were received. A copy of the official Bid Tabulation is enclosed. The contractors which submitted bids and their respective bid amounts are as follows:

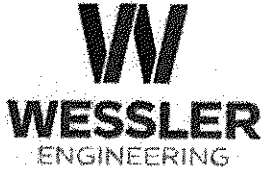
The engineer's estimate for the project was \$2,350,000. The low bid was approximately 12% below the engineer's estimate.

We have reviewed the bid package for the low bidder, Mitchell & Stark Construction, and the bid documents appear to be complete. Based on the evaluation of their experience and qualifications it appears that they are capable and qualified to perform the work required.

Pursuant to the Contract Documents, the Board may reject any and all bids, may accept the Lump Sum Base Bid Price, or may accept the Total Base Bid Price.

Should the Board choose to award the Project, based upon the bids received and information obtained on the low bidder, we recommend the Notice of Award be made to Mitchell & Stark Construction at the Total Base Bid Contract Price of \$2,077,900.00.
