The finalized rules will be sent out to the Council members, and if there are no further issues the Council approved by consensus forwarding the rules to the Board of Works with our recommendation to adopt.

4) New Business:

- a) Pandemic update from Rick Littleton the VPN access and IP telephony was successful for work at home.
- b) Rick is working to identify vendors and requirements and vendors for FPD body cameras.
- c) The process to upgrade the Kronos timekeeping system to their newer "Workforce Ready Time Keeping" has begun
- d) The planned upgrade of the Mitel Phone system to the new platform will begin in late 2020 as the existing platforms End of Life is June 2021. The upgrade should be cost neutral.
- e) The CARES Act provides grant moneys for COVID related expenses through 12-31-2020.
 - i) Parks and Recreation are installing a new camera with AI to count people as they enter the pool in order to maintain the CDC recommended limits.
 - ii) The Parks and Recreation will also implement thermal scanning at the Recreation Center.
 - iii) RFQs have been issued to permit live streaming of meetings, and then provide indexed videos for public access.
