**WHEREAS**, it has been determined that it is now necessary to reduce the appropriation in the MVH Fund-Capital in the amount of \$ 500,000.00 and LRS Fund-Capital in the amount of \$44,554.00 due to the transfer of MVH & LRS funds to the Local Road & Bridge Matching Grant Fund.
