A RESOLUTION AUTHORIZING A FIVE-YEAR CONTINUATION OF THE INTERLOCAL ASSOCIATION

WHEREAS, the Common Council is the legislative body of government for the City of Franklin, Indiana; and

WHEREAS, the City of Franklin, in cooperation and agreement with other Local Governmental Units did enter into an Interlocal Association in accordance with the Interlocal Cooperation Act of the State of Indiana providing for cooperation between municipalities and parties, in their mutual best interest, to establish a formal association through which the costs and benefits of Workforce training and technical assistance may be shared; and

WHEREAS, the City of Franklin, deems it in the best interest of its citizens and residents to continue that Interlocal Association originally entered into pursuant to a Joint Resolution and Articles of Agreement dated August 27, 1973; and

WHEREAS, it is desirable, advantageous, and in the public interest to continue the agreement for joint and cooperative action, as described in the Joint Resolution and Articles of Agreement of the Interlocal Association and as authorized by the Interlocal Cooperation Act of Indiana; and

WHEREAS, section two of the Joint Resolution and Articles of Agreement originally adopted on August 27, 1973, provides that the agreement shall be renewed for five-year periods upon appropriate action of the legislative bodies of member units of government.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, THAT:

The City of Franklin, hereby resolves to join with other local units of government in the continuation of the Interlocal Association as described in the Joint Resolution and Articles of Agreement previously authorized;

NOW, THEREFORE, the below elected officials authorize the City of Franklin to take actions as permitted in said agreement and as authorized by the powers which now, or hereafter, may be conferred by law upon the City of Franklin and the parties to the Joint Resolution and Articles of Agreement.
