Pursuant to IND. CODE § 36-8-3.5-12, the Franklin Police Merit Commission has, over the last three months, conducted a competitive process to develop an applicant eligibility list for new Merit Officers. The prior list was to have been effective through December 31, 2022. That list has been exhausted, however, necessitating the current process which has now been concluded with the Commission's certification of a ranked eligibility list based on the statutory procedures, Commission rules, and the assistance of the Commission's testing vendor, Testing For Public Safety, LLC.

Pursuant to subpart (e) of the cited statute, enclosed please find the certification of the applicant eligibility list from the Commission to the Franklin Board of Public Works and Safety.

As we have discussed in the past, the statute requires no formal action by the Board of Public Works and Safety; it merely requires the Commission to certify the list to the Board.

RESOLUTION CERTIFYING APPLICANT ELIGIBILITY LIST

WHEREAS, Indiana Code § 36-8-3.5-12(e) and (f) require Police Merit Commissions to create and maintain biennial lists of eligible applicants for appointment as Merit Police Officers (hereinafter "Applicant Eligibility Lists") and to certify those lists to the safety board of their respective municipalities as they are created, and;

WHEREAS, the safety board of the City of Franklin is the Franklin Board of Public Works and Safety, and;

WHEREAS, the City of Franklin has, by its duly adopted Ordinances, created the Franklin Police Merit Commission, which, through its duly adopted *Rules and Procedures for Governance, Appointments, Promotions, Demotions, and Disciplinary Actions*, regularly creates and maintains its Applicant Eligibility Lists, each such List being effective until the earlier of two years from the date of certification of the List or its exhaustion, and;

WHEREAS, the Franklin Police Merit Commission has conducted a statutorily-compliant competitive process to create a new Applicant Eligibility List, and;

WHEREAS, upon the conclusion of that process and the calculation of applicants' scores therein, the Franklin Police Merit Commission met on March 7, 2023, and approved the Applicant Eligibility List attached hereto and incorporated herein as Exhibit "A" to be effective March 7, 2023;

NOW THEREFORE, we the undersigned members of the Franklin Police Merit Commission do hereby offer and certify this Resolution Certifying Applicant Eligibility List to the Franklin Board of Public Works and Safety, all as provided herein.




