SUPPLEMENTAL AGREEMENT NO. 1

This supplemental agreement is made and entered into, 20	<u>)23</u> , by
and between the CITY OF FRANKLIN, INDIANA, acting by and through its proper officials (herei	inafter
referred to as "LPA") and GAI CONSULTANTS, INC., (hereinafter referred to as the "CONSULTA	ANT").

WITNESSETH

WHEREAS, LPA and the CONSULTANT did, on July 6, 2021, enter into a contract for specific professional services for Yandes Street Reconstruction from East Jefferson Street to Ohio Street, and Madison Street from Yandes Street to Depot Street ("Project").

WHEREAS, CONSULTANT requests compensation for services to cover its costs resulting from additional inspection effort due to unexpected utility conflicts and increased construction cost, summarized in the man-hour justification attached as EXHIBIT "1".

WHEREAS, in order to provide for this additional compensation, it is necessary to amend and supplement the contract.

NOW, THEREFORE, it is agreed by and between the parties as follows:

1. <u>SECTION IV</u>, <u>COMPENSATION</u> is amended to read as follows:

The LPA shall pay the CONSULTANT for the Services performed under this Contract as set forth in Section 4 which is herein attached to and made an integral part of this Contract. The original contract amount of \$248,400.00 is being increased through this Supplemental Agreement No. 1 by \$120,000.00. Therefore, the maximum amount payable under this Contract shall not exceed \$368,400.00.

2. Except as herein modified, changed and supplemented, all terms of the original contract dated July 6, 2021 shall continue in full force and effect.

Non Collusion - The undersigned attests, subject to the penalties for perjury, that he/she is the contracting party, or that he/she is the representative, agent, member or officer of the contracting party, that he/she has not, nor has any other member, employee, representative, agent or officer of the firm, company, corporation or partnership represented by him/her, directly or indirectly, to the best of his/her knowledge, entered into or offered to enter into any combination, collusion or agreement to receive or pay, and that he/she has not received or paid any sum of money or other consideration for the execution of this agreement other than that which appears upon the face of the agreement.
