- 14. **Buyers Non-Payment:** In the event of a nonpayment by the buyer, Auctioneer, in its sole discretion may a) offer the property at a future auction, or b) cancel the sale and return the property to the Seller. Auctioneer is not a guarantor of payment and shall not, under any circumstance, be liable to Seller for any direct, indirect, consequential, punitive, special, or exemplary damages or lost profit as a result of buyer's non-payment.
