Below is the breakout for the final deduct cost for this project. Mitchell & Stark was allowed to switch from ductile iron wall pipes to cell cast forming blocks and links seal because of the long lead time on these wall pipes. This resulted in a cost savings for these items. Mitchell & Stark performed additional work on the basement handrail and added additional filters on the non-potable water lines, this resulted in additional cost. Below is the breakout of the deduct and the additional work.
