## d. Additional appropriation for Athletic & Recreation Fund

## e. Beeson Hall catering contract

Six caterers provided food for the Board and Parks employee samplings. A discussion was held regarding the number of caterers for the 2010 – 2012 contract term. Information was previously provided to each Board member from seven caterers for their considerations. The Board was directed by Chip to further review the caterer's information and come to the September meeting with their recommendations. The Board asked to receive information from Holly Johnston, Administrative Services Coordinator, since she is directly involved with all facility rentals, individual caterers and clients.

## f. Administration

The State Board of Accounts visited the Parks Department in early July to audit 2008. There were multiple errors in the Access program that the Accountant stated needed to be identified. That request has already been addressed.

## g. Recreation/Special Events

#### 1. Fall Festival

Festival will be October 3, 2009. Entertainment will be provided by the "Polka Boys." The Parks Department will be working with the Police Department to close specific streets for the event. It is our hope to move the mobile stage to the north of the Madison St./N. Main Street intersection to allow for more guest space for the entertainment area.

## 2. Haunted Trail planning

Chip announced that Sammy Terry will be here Fri. Oct. 30, 2009 for the opening of the Haunted Trail from 6 – 9 pm that will be \$5.00 per person. The Haunted Trail will be throughout Province Park.

## h. Parks/Facilities

## 2. Park Flooding update

Significant flooding again occurred in Province Park. There was excessive water in Province Park, Blue Heron Park, Community Park, the CARC Theater and Lobby and damage to the asphalt on the Creekside Bridge. Deep cleaning will be required at the Community Park tennis/basketball courts.

## i. Swimming Pool

Attendance numbers and monies were up from previous years. Pool passes were reduced to  $\frac{1}{2}$  price for the remainder of the season with closing scheduled for Sept. 7, 2009 weather permitting.
