4. Consent Agenda

- a. Approval of meeting minutes from January 12, 2012 and January 20, 2012.

5. Old Business

a. Greenway Trail Projects

1. Approval to initiate legal action for trail expansion to Paris Estates

After a brief discussion on the trail expansion to Paris Estates a motion was made by Pam Ault and seconded by Ted Server to proceed with legal actions of eminent domain for property owned by Dr. Allen Paris. The Board unanimously approved.

2. Approval to initiate survey work for the FCHS to Knollwood Farms Trail

After a brief discussion a motion was made to initiate survey work for the FCHS to Knollwood Farm Trail project including connection to the North Pointe subdivison by John Shafer and seconded by Ted Server. The Board unanimously approved. The trail will be approximately 1.3 miles. Park Board Attorney J. Andrew Woods will prepare the appropriate paperwork.

b. Flood Buyout Areas Maintenance

Chip informed the Board that the current grant does NOT include the fees for mowing and maintenance of the flood buyout area.

6. **New Business**

a. Approval of Quit Claim Deed – 291 E. Monroe Street

A motion was made by Pam Ault and seconded by John Shafer to approve the Quit Claim Deed for the property at 291 E. Monroe Street. The Board unanimously approved. The paperwork was given to J. Andrew Woods for signature and submission.

b. Approval to recommend the 2012 Bond Issue projects to the City Council

Chip reported he had met with Mayor McGuinness and Janet Alexander regarding the 2012 Bond Issue. He stated a bond counsel was selected to develop a time line for the bond. It will be an extension of the current debt with the same payment. A motion was made by Pam Ault and seconded by John Shafer recommending the 2012 Bond issue project be sent to the City Council. The Board unanimously approved.
