a. Park Board Resolution 2013-01: Increasing Credit Card Limit from \$5,000 to \$10,000 Motion was made by Dr. John Shafer and seconded by Pam Ault to increase the credit card spending limit for Sam's Club Direct account from \$5000 to \$10,000 to allow spending needs for the summer concessions, Kickapoo Kids Camp, pool and Active Adult needs. The Board unanimously approved.

b. Proposed Mower Lease for Park Operations

Motion was made by Michael Auger and seconded by Pam Ault to approve the proposed mower lease with MacAllister Machinery Company, Inc. for a 60" ZTR Kubota Gas mower. The lease will be paid in two payments including June 2013 and January 2014 in the amount of \$9,400.00. The Board unanimously approved.

a. Park Bond projects

Family Aquatic Center progress final update

The project is almost complete. The slide canopy will be installed on Sunday. A handrail will be installed at the steps between the two pool areas next week. The mechanical systems will be running within the week.

b. Recreation/Fitness Center progress final update

The office space is nearing completion. Carpeting still needs to be installed in the Community Events/Program Directors office. It will be done next week.

The Fitness Room expansion is complete.

c. Pool Bath House Renovation progress final update

This project is complete.

d. Pool Concession Stand progress final update

The concrete in front of the concession stand has cracked and needs to be repaired before the pool opening.

e. Parking Lot Renovation/Expansion project final update

This project is nearing completion. It has suffered some weather setbacks. Paving will be completed from the Creekside bridge to the triangular intersection by the King Shelter. The Park road from South Street to North Home Avenue will also be paved. Motion was made by Pam Ault and seconded by Dr. John Shafer to approve King's Trucking and Excavation to complete this work. The Board unanimously approved.
