BUDGETARY ORDINANCE No.: 09-09

CREATION OF PERSONAL SERVICES BUDGETARY LINE ITEMS AND ADDITIONAL APPROPRIATION ORDINANCE

WHEREAS, it has been determined that it is now necessary to create budgetary Personal Services line items for full-time and part-time salaries and appropriate more money than was appropriated in the Rainy Day Fund 2009 annual budget for Personal Services for the remainder of the year; now therefore:

Sec.1. Be it ordained by the Common Council of City of Franklin, Indiana that for the expenses of the taxing unit the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to the laws governing the same:

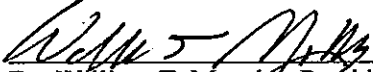
