Ordinance 09-03 OF THE CITY OF FRANKLIN, INDIANA

An Ordinance Repealing Ordinance 747 and Chapter 2.36 of the City Code for the City of Franklin, Indiana

WHEREAS, the Common Council of the City of Franklin, Indiana finds that the Human Relations Commission is obsolete and non-existent, and a portion of the City Code is obsolete;

WHEREAS, the Common Council has determined it appropriate and beneficial to the City to repeal such ordinances and portions of the City Code;

Now, therefore, the Common Council of the City of Franklin, Indiana, Ordains and Enacts the following:

- Section 1. Ordinance 747 is hereby repealed.
- Section 2. Chapter 2.36 of the City Code is hereby repealed.

Section 3. Duration and Effective Date: The provisions set forth in this ordinance become and will remain in full force and effect on day of the passage and adoption of this ordinance by signature of the executive in the manner prescribed by Indiana Code §§ 6-4-6-15, 16.
