

Ordinance 09-03
OF THE CITY OF FRANKLIN, INDIANA

**An Ordinance Repealing Ordinance 747 and Chapter 2.36 of the City Code
for the City of Franklin, Indiana**

WHEREAS, the Common Council of the City of Franklin, Indiana finds that the Human Relations Commission is obsolete and non-existent, and a portion of the City Code is obsolete;

WHEREAS, the Common Council has determined it appropriate and beneficial to the City to repeal such ordinances and portions of the City Code;

Now, therefore, the Common Council of the City of Franklin, Indiana, Ordains and Enacts the following:

Section 1. Ordinance 747 is hereby repealed.

Section 2. Chapter 2.36 of the City Code is hereby repealed.

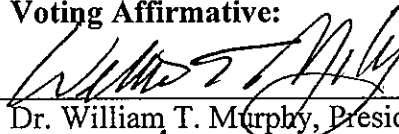
