Minutes of Meeting

1) Call to Order: The meeting was called to order at approximately 8:00 a.m.

3) New Business:

a) Robert H. Schafstall introduced representatives from Ivy Tech Community College and advised the Members that Ivy Tech wants to relocate in order to meet the needs of their growing population. The representatives explained that Ivy Tech is increasing their presence in Johnson County and has become an affordable option for students. Dave Donnell, Facilities Director, provided the Commission with an overview of the need for more space, including additional parking. The proposed location for the relocation is along McClain Drive. Discussion held. Mr. Donnell explained that the current plan includes four (4) phases, in which the first phase is estimated at \$550,000, in which the current lease with the hospital expires fall 2008.

Robert H. Schafstall recommended that the Commission allow him to continue conversations with Ivy Tech in order to identify options for collaboration between the City of Franklin and Ivy Tech. The Commission provided their consensus.

- b) Rob Shilts, Executive Director Franklin Heritage and Art Craft Theatre, appeared before the Commission to provide the members with an update in regard to Franklin Heritage. Mr. Shilts explained that the Franklin Heritage has been in existence for 10 years and provided members with updated information on their restoration projects. Mr. Shilts specifically discussed the property located at 901 East Jefferson Street. Mr. Shilts expressed his concern with continuing work on properties due the property taxes. Mr. Shilts explained that he is requesting assistance from the RDC in regard to the property taxes during the construction phases of such properties.
- c) Krista Linke, Staff Planner for the City of Franklin, appeared before the Commission to discuss revitalization efforts with the City and possible ways that the RDC could provide assistance to future businesses. Ms. Linke presented a memo to the members that outlined four recommendations to encourage quality downtown redevelopment:

 1. establish a revolving loan fund to provide low interest loans to small businesses; 2. provide small business management assistance; 3. establish a building rehabilitation matching grant program, and 4. purchase a commercial property to rehabilitate and lease tenant spaces. Mayor Jones-Matthews discussed her support of these options. The Commission requested that Mr. Schafstall determine how the interest from the TIF funds can be utilized, in which currently the interest is being placed in the General Fund.
- d) Cheryl Morphew, Johnson County Development Corporation, appeared before the Commission to encourage the City to identify options/strategies to prepare for the next project, which may include resources for training/professional development. Ms. Morphew explained that a current Indiana manufacturing and distributing company needs to relocate and the final Indiana site is Franklin Tech Park. If the company is unable to relocate to Franklin, it will relocate in another state. The current options include, abatement, preparing the site to be "pad" ready, moving a street, and assistance in purchase of equipment (approximately \$44 million). Mayor Jones-Matthews will be preparing a final letter to the company with incentives that the City of Franklin can provide.

4) Old Business:

- a) Minutes: Mr. Ted Grossnickle, seconded by Mr. Brian J. Deppe, made a motion to approve the minutes from the meeting held June 7, 2007. The motion carried and the minutes were approved.
- b) Robert H. Schafstall offered an update on the Hazelett Building, in which they have changed realtors to Jarvis Realty. Mr. Schafstall recommended that the RDC move forward with the request for proposal idea. Mr. Schafstall proposed that he would prepare a Request for Proposal (RFP) to be approved at that next meeting.

- c) Joe Csikos, Planning Director, provided the members with a memo from City Engineer Mike Buening. Robert H. Schafstall referred to the memo and requested direction from the Commission. The Commission requested that Mr. Schafstall prepare resolutions related to the culvert and paving to be addressed at the next meeting.
- 4) Other Business: None came before the Commission.
- 5) Adjournment: the meeting was adjourned by unanimous consent at approximately 9:30 a.m. The next meeting is scheduled for September 6, 2007 at 8:00 a.m.

Re: Tech Park Drainage

Part of the tech park original Johnson County Drainage Board approval included a culvert replacement on CR 550 East. This was required to provide adequate capacity at the culvert for the drainage flows from the developed site. Denison Properties received Johnson County approval for plans to replace the culvert and has submitted bid information to staff with the low bid from Duncan Robertson being in the amount of \$84,528.

Denison has requested that the RDC approve the use of TIF funds from the Franklin Eastside district for this project.

If approved, I would recommend that the TIF funds be reimbursed to Denison Properties after completion of the culvert installation.
