## ORDINANCE NUMBER 10-14 OF THE CITY OF FRANKLIN, INDIANA

## AN ORDINANCE AUTHORIZING THE CREATION OF A CASH CHANGE FUND FOR THE PLANNING DEPARTMENT

WHEREAS, the City of Franklin, Indiana Planning Department currently has a need for a cash change fund for the purpose of making change for patrons;

WHEREAS, the Common Council may establish a cash change fund according to Indiana Code 36-1-8-2;

Now, Therefore, The Common Council of the City of Franklin, Indiana, Ordains and Enacts the following:

- 1. **Creation of Cash Change Fund.** The below-referenced cash change account for the Franklin Planning Department be established in the amount specified;
- 2. Construction of Clause Headings. The clause headings appearing in this ordinance have been provided for convenience and reference, and do not purport and will not be deemed to define, limit, or extend the scope or intent of the clauses to which the headings pertain;
- 3. Repeal of Conflicting Ordinances. The provisions of all other ordinances in conflict with the provisions of this ordinance are of no further force or effect, and are now repealed;
- 4. Severability of Provisions. If any part of this ordinance is held to be invalid, such part will be deemed severable and its invalidity will have no effect upon the remaining provisions of this ordinance;
- 5. **Duration and Effective Date**. The provisions set forth in this ordinance become and will remain in full force and effect (until their repeal by ordinance) on day of the passage and adoption of this ordinance by signature of the executive in the manner prescribed by Indiana Code §§ 6-4-6-15, 16.
