ADDITIONAL APPROPRIATION ORDINANCE

WHEREAS, it has been determined that the City of Franklin Police Department was awarded grant monies from the Johnson County Citizens Against Substance Abuse (JCCASA) in the amount of \$9,500.00 to assist in the operations of the Narcotics Unit;

WHEREAS, the monies from the Grantor were deposited into the Grants/Police Fund 230;

WHEREAS, it is necessary to appropriate the grant monies into operating line items within Grants/Police Fund 230 according to the guidelines of the grant proposal;

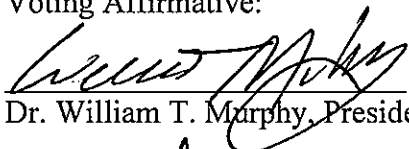
