## ORDINANCE NUMBER 10-12 OF THE CITY OF FRANKLIN, INDIANA

## AN ORDINANCE ESTABLISHING A DRUG-TESTING FEE AND CREATING A FUND FOR THE ADMINISTRATION OF SAME (Amended After Introduction)

WHEREAS, the City of Franklin, Indiana periodically establishes fees for services provided with respect to the operation of the Franklin Police Department and its personnel.

WHEREAS, those fees need to be revised.

Now, Therefore, The Common Council of the City of Franklin, Indiana, Ordains and Enacts the following:

- 1) **Drug-Testing Fee.** In the event the Franklin Police Department is called upon to perform a Marijuana Analysis, a Drug-Testing Fee in the amount of Fifty Dollars (\$50.00) will be imposed for each test performed by the Franklin Police Department Crime Lab Technician. A bill for said services will be forward by the Police Department to the County Prosecutor. Any payments received will be delivered to the Clerk Treasurer and receipted into the General Fund.
- 2) Construction of Clause Headings. The clause headings appearing in this ordinance have been provided for convenience and reference, and do not purport and will not be deemed to define, limit, or extend the scope or intent of the clauses to which the headings pertain;
- 3) Repeal of Conflicting Ordinances. The provisions of all other ordinances in conflict with the provisions of this ordinance are of no further force or effect, and are now repealed;
- 4) Severability of Provisions. If any part of this ordinance is held to be invalid, such part will be deemed severable and its invalidity will have no effect upon the remaining provisions of this ordinance;
- 5) **Duration and Effective Date**. The provisions set forth in this ordinance become and will remain in full force and effect (until their repeal by ordinance) on day of the passage and adoption of this ordinance by signature of the executive in the manner prescribed by Indiana Code §§ 6-4-6-15, 16.

Introduced and Filed on the 20th day of September, 2010. A motion to consider same on the First Reading or day of introduction was not offered.

DULY PASSED on this 4th day of October, 2010 by the Common Council of the City of Franklin, Johnson County, Indiana, having been passed by a vote 6 in Favor and 0 Opposed.
