Mayor Blankenship lead the Board in a recitation of the Pledge of Allegiance. No one from the media was present.

FRANKLIN TECH PARK SEWER PROJECT

Mayor Blankenship asked Mr. Ott, the City Engineer, to provide an overview of the project. Mr. Ott summarized his recommendations from his report, "<u>Preliminary Feasibility Study Franklin Tech Park Sanitary Sewer Service Draft</u>". The report outlined three options for the City. Mr. Ott stated that in his opinion the most cost effective solution would be Option #3. Mr. Ott also suggested that the City could recover some of its' expenses by assessing a fee beyond the normal connection fees to recapture some of the capital expense. The following table is an excerpt from the report.

Mr. Joseph Csikos the Staff Planner stated that the Planning Office reviewed the options outlined and recommends Option 3. Mr. Csikos stated that the third option addresses several City goals and policies, and provides the greatest long-term benefit and development opportunity to the City.

Mr. Rick Littleton Superintendent of the Wastewater Treatment Plant stated that he concurred with the Mr. Ott's report. He also stated that he prefers Option 3. Mr. Littleton submitted a letter from the Johnson County Health Department supporting the proposed project.

Mr. Jeffery W. Birk, CPA of Birk, Gross, Bell, & Coulter, an accountant hired by the City to review the Sewage Utilities finances, stated that the utility has sufficient net operating reserves to pay for this project without outside financing and without increasing user rates. Mr. Birk suggested the Board could recover the capital costs with an assessment to future users.

Mr. Hougland stated that he favors Option 3 and would like to proceed as if the Board has selected Option 3, but bid out both Option 3 & Option 2, in light of current events (terrorist attacks on the World Trade Center in New York City and Washington D.C. and the decline in the Stock Market). Mayor Blankenship agreed with Mr. Hougland and stated that in light of recent events he supports Option 3. Mr. Hougland seconded by Mayor Blankenship, made a motion to bid Options 2 & 3. Motion carried

As there was no further business to come before the Board, the meeting adjourned at 6:40 p.m.
