After the Invocation and the Pledge of Allegiance, Mr. Hougland, seconded by Mayor Blankenship made a motion to approve the minutes of the May 29, 2001 meeting as distributed. The motion carried.

The Clerk Treasurer presented the following claims for approval: Fifth Third Bank 22970 - 23072 Heartland Bank 3953 - 3963. Payroll 06-1-01 90000 – 90005. Mr. Hougland moved to approve the claims as presented. Mayor Blankenship seconded this motion. The motion passed.

The Mayor reorganized the agenda to allow the following matters to be heard first.

**Simon Commercial Subdivision Plat Approval** – Mr. Steve Williams appears representing the petitioner. Mr. Weir stated that the Planning Department recommends that the Board accept the public dedications and approve the Final Plat presented. Mr. Williams presented an Irrevocable letter of Credit No. 351845994 9644834000 from Union Federal Bank for up to \$40,000.00, which expires June 8 2002. Mr. Hougland made a motion to approve, seconded by Mayor Blankenship. Motion carried.

**Stop Sign at Knollwood and Cottonwood in Knollwood Farms** – Ms. Shirley Scalf appears and requests the Board consider installing a stop sign at this location. This was referred to the Planning Office for review. Mayor Blankenship seconded by Mr. Hougland made a motion to table until June 26, 2001. Tabled

**Cemetery Cannon Review** – City Attorney David Denslaw stated that the State Museum requested the amount of insurance the City would require for the Cannon. Mayor Blankenship seconded by Mr. Hougland made a motion to recommend that the cannon be insured to \$100,000.00. Motion carried.

**Policy Manual Discussion** – Mayor Blankenship stated that he has scheduled an open meeting for Department Heads and Staff June 18<sup>th</sup> to review & discuss the proposed the policy manual. Tabled

**Curfew Law Review** – Chief John Borges recommended a tiered fine for violations. Mayor Blankenship asked that an amendment to the current ordinance be drafted and until the draft is presented that this matter to be tabled.

**Street Cut Standards** – Mr. Ott provided guidelines to the Mayor that had been adopted for the Sewer Maintenance Department as a recommendation. Mr. Hougland seconded by the Mayor made a motion to table this until June 26, 2001. Tabled.

Interlocal Agreements between City of Franklin and Johnson County – Mayor Blankenship asked the City Attorney / or Mr. Weir to contact the County Attorney regarding finalizing the GIS agreement. The Mayor also stated that the Graham Road agreement is still up in air as is the agreement concerning fees. Mayor Blankenship made a motion to table seconded by Mr. Hougland. Tabled

**Paris Estates Stop Signs** – Mr. Weir reviewed the area and stated that he did not believe that additional stop signs should be added. The Mayor asked him and Mr. Hughes to speak with the resident who made this request before the Board acted. Just recently the Street Department added speed limit signs. Mr. Hougland seconded by Mayor Blankenship made a motion to table. Tabled.

**INDOT Proposals, US 31 & S.R. 44** – The Mayor stated that the Knollwood Homeowners Association would like to meet with City representatives concerning this proposal. Mr. Ott asked the Mayor to discuss the traffic issues at the intersection at U.S. 31 and S.R. 44. Mayor Blankenship asked the Engineer to contact the business owners at those locations and inform them that the City is considering turning restrictions.
