After the Invocation and the Pledge of Allegiance, Mr. Hougland made a motion to approve the minutes of the April 25, 2000 meeting as distributed. Mr. Ault seconded this motion. The motion passed.

OLD BUSINESS

Jack Rogers - Re: Railroad Right of Ways: Removed pending request of petitioner.

<u>Family Wealth Counseling Encroachment Agreement</u>: Motion made by Mr. Ault seconded by Mr. Hougland to table the presentation of the final draft of the agreement between the City and Family Wealth Counseling until the May 23, 2000 Board of Works meeting. Tabled

<u>Penny Lovell – Drainage at 767 S. Main St.</u>: Mrs. Penny Lovell and Mr. Bob Lovell returned to ask the Board to consider improvements on S. Main to alleviate the drainage problem at their property. Mr. Ott explained the problem to the Board. Mr. Ott offered a speed bump as a short-term solution. The property owners agreed to the speed bump and asked the City to proceed as soon as possible.

NEW BUSINESS

<u>Drainage Improvement Knollwood Farms</u>: Jerry Ott made a report to the Board concerning work done by Mr. Richard Cornell at his property at 4155 Knollwood Court. Mr. Cornell explained his actions to the Board. Mr. Scott Tanner, an attorney appeared, representing the Homeowners Association of Knollwood Farms to discuss the changes made by Mr. Cornell. A discussion was held. Jerry Ott recommends that the Sewer Department use their camera to examine the interior of the newly laid pipe to be certain that the pipe is intact. The Board tabled the matter until the next Board meeting. Neighbor Mr. Cress spoke to the Board in support of Mr. Cornell's effort. Tabled

E-mail to Mayor Re: 1199 Oak Leaf Manor – Property Owners requested a "Dead End Street sign": Motion made by Mr. Hougland, seconded by Mr. Ault to install a sign at the requested location. Motion passed. Mr. Bergman will contact Carol Patterson at the Street Department. Speed limit signs are also needed in the Oak Leaf addition. Mr. Ott and Mr. Bergman will investigate the placement of speed limit signs.

<u>Marcia Schumacher:</u> Franklin Band Boosters request to hang banners across Jefferson St. announcing the Circus at Johnson County Fairgrounds June 2, 2000. Motion made by Mr. Hougland to allow Franklin Band Boosters to hang the two banners pending State approval. Seconded by Mr. Ault. Motion passed.

Franklin Lions Club: Request to set up tent for their fish fry June 16th and 17th, in the City parking lot at the corner of Water and Monroe St.. Mr. Hougland made a motion to allow the tent. Mr. Ault seconded. Motion passed.

<u>Jean Cox – requesting a handicap parking designation at her residence:</u> Upon Ms. Cox's request this item is removed from the agenda.

<u>Larry Buck:</u> Discussion of alley maintenance. Mr. Buck appears to support his request for maintenance of the alley, which fronts his business. Jerry Ott will look at the location and make a recommendation to the Board. Tabled until May 23rd @ 6:00 p.m. pending staff reports.

<u>Charles Claxton:</u> The Mayor read a letter from the homeowners requesting a "Slow Children at Play" signs in front of their home. The Board will request that the Police Department increase enforcement at this location. Mr. Hougland made the motion to table pending reports from the Police Dept. Mr. Ault seconded the motion. Motion carried. Tabled.

<u>Don Henry Memorial Ride and Benefit for the American Cancer Society:</u> Sara Henry requests reserved parking for motorcycles in front of Henry's Grill Bar from Home Ave. and Water St. June 3rd from 5:00 p.m. till 11:00 p.m. Motion made by Mr. Ault seconded by Mr. Hougland to approve the request made by Sara Henry. Motion passed.

Rumpke sent a copy of their monthly *Waste and Recycle Report*, which the Mayor provided, to the Board members.

Mayor Blankenship pointed out that he had provided copies of a letter to the Board from Ray Temple of the Temple Group.
