ORDINANCE NUMBER 2012-15 OF THE CITY OF FRANKLIN, INDIANA

AN ORDINANCE APPROVING VACATING RIGHT-OF-WAY WITHIN THE CITY OF FRANKLIN, INDIANA BETWEEN LOTS 36 & 60 and 37 & 59 OF CRIM'S ADDITION (To be known as Crim's Addition Lots 36 & 60 and 37 & 59 Alley Vacation)

WHEREAS, City of Franklin has filed before the Common Council of the City of Franklin a petition requesting that said public right-of-way as described herein be vacated for the reason that said public ways are not at this time used for any public purpose and are not foreseeably needed by the City of Franklin for any public purpose; and

WHEREAS, subject public way is an alley 12 feet in width and runs east and west 268 feet along the south boundary of lots 36 & 60 and north boundary of lots 37 & 59 in Crim's Addition, an addition to the City of Franklin as recorded in Plat Book 2, Page 63 in the Office of the Recorder of Johnson County, Indiana;

WHEREAS, the notices and advertisements required by IC 36-7-3-12 have been given, and a public hearing was held upon said petition on the _4th day of _June ______, 2012.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, ORDAINS THAT:

- 1) The public way described above is hereby, pursuant to IC 36-7-3-12, declared vacated;
- 2) Any utility easements shall remain for the length and width of the vacated right-of-way;
- 3) A copy of this Ordinance shall be transmitted to the Recorder of Johnson County, Indiana;
- 4) This Ordinance shall become effective at the time of recording;
- 5) City Staff is authorized to execute all deeds necessary in accomplishment of the herein above.

PASSED on this 4th day of June , 2012, by the Common Council of the City of Franklin, Johnson County, Indiana, having been passed by a vote of 6 in Favor and 0 Opposed.
