

ORDINANCE NUMBER 2012-16 OF THE CITY OF FRANKLIN, INDIANA

AN ORDINANCE APPROVING VACATING RIGHT-OF-WAY WITHIN THE CITY OF FRANKLIN, INDIANA BETWEEN LOTS 35, 36, 37 & 38 and 58, 59, 60 & 61 OF CRIM'S ADDITION (To be known as Crim's Addition Lots 35, 36, 37 & 38 and 58, 59, 60 & 61 Alley Vacation)

WHEREAS, City of Franklin and Carolyn Moore has filed before the Common Council of the City of Franklin a petition requesting that said public right-of-way as described herein be vacated for the reason that said public ways are not at this time used for any public purpose and are not foreseeably needed by the City of Franklin for any public purpose; and

WHEREAS, subject public way is an alley 12 feet in width and runs north and south 252 feet along the west boundary of lots 35, 36, 37 & 38 and east boundary of lots 58, 59, 60 & 61 in Crim's Addition, an addition to the City of Franklin as recorded in Plat Book 2, Page 63 in the Office of the Recorder of Johnson County, Indiana;

WHEREAS, the notices and advertisements required by IC 36-7-3-12 have been given, and a public hearing was held upon said petition on the 4th day of June _____, 2012.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, ORDAINS THAT:

- 1) The public way described above is hereby, pursuant to IC 36-7-3-12, declared vacated;
- 2) Any utility easements shall remain for the length and width of the vacated right-of-way;
- 3) A copy of this Ordinance shall be transmitted to the Recorder of Johnson County, Indiana;
- 4) This Ordinance shall become effective at the time of recording;
- 5) City Staff is authorized to execute all deeds necessary in accomplishment of the herein above.
