AN ADDITIONAL APPROPRIATION ORDINANCE APPROPRIATING MONIES FROM THE UNSAFE BUILDING FUND

WHEREAS, monies are needed in the Unsafe Building Fund budget for professional services expenses for the remainder of 2012; and

WHEREAS, Indiana Code 36-7-9-14 (b) states that money for the unsafe building fund may be received from any source including appropriations by local, state, or federal governments and donations; and

WHEREAS, the Common Council of the City of Franklin Indiana transferred \$1,375,000 from the in the Rainy Day Fund into the Unsafe Building Fund for the purpose of funding anticipated professional services in 2012; and

WHEREAS, the monies from the Rainy Day Fund were deposited into the Unsafe Building Fund 250; and

WHEREAS, it is necessary to appropriate the Unsafe Building Fund monies into operating line items according to the State Board of Accounts guidelines; and

THEREFORE, it is ordained by the Common Council of City of Franklin, Indiana that the following amounts of money are hereby appropriated from the Unsafe Building Fund into the stated line items for the purposes specified, subject to the laws governing the same:
