Mayor Paris opened the meeting and asked the Clerk-Treasurer to call the roll. Dr. Murphy offered the invocation, which was followed by a recitation of the Pledge of Allegiance.

Mayor Paris made note that today is the second anniversary of the flood of 2008.

CONSENT AGENDA

Mayor Paris presented the consent agenda for approval.

o Approval of the May 17, 2010 Common Council Minutes

Dr. Murphy, seconded by Mrs. Gordon, made a motion to approve the consent agenda as presented. The motion carried and the consent agenda was approved.

ANNOUNCEMENTS, PRESENTATIONS & COUNCIL MEMBER COMMENTS

Mayor Paris asked if anyone from the public wished to speak on any matter not listed on the agenda.

Resident Gary Moody came forward and presented his thoughts on the proposed sale of the old City Hall and former Post Office. In advance of this meeting Mr. Moody dropped off copies of a petition for the Council Members which he circulated supporting his position that this building should be converted into a new home for the Franklin City Court. A discussion was held involving Mayor Paris, Mr. Barnett, Mr. Austin, and Mr. Abban. Mayor Paris stated that the decision concerning the sale of that building is the purview of the Board of Public Works and Safety. Mayor Paris read a prepared statement concerning his position on the sale of the building.

OLD BUSINESS

City of Franklin Budgetary Ordinance No.: 10-06: A Common Council Budgetary Ordinance Authorizing an Additional Appropriation of \$500,000 in the Rainy Day Fund

Senior Planner Joanna Myers came forward to give an update on the buyout project. The requested appropriation is needed to continue the buyout project and to avoid delays caused by delayed payments from the State of Indiana. A motion and a second were made to read by title only. Mayor Paris read the ordinance aloud and stated that this is the public hearing for the requested additional appropriation and he asked whether anyone wished to speak for or against the proposed ordinance, however, no one asked to speak. Mayor Paris closed the public hearing and Dr. Murphy, seconded by Mrs. Gordon made a motion to approve the ordinance. The motion carried and the ordinance was approved.

Introductions

Ordinance 2010-09: An Ordinance Approving Resolution Number 2010-11 of the City of Franklin, Indiana Plan Commission, Rezoning Certain Property to Planned Unit Development (PUD) (To be known as the Franklin College of Indiana Rezoning)

- August 2, 2010: Public Hearing on Salary Ordinances and Introduction of City Budget (1st reading)
- (The proposed budget must be published two (2) times before the first public hearing.)
- August 4, 2010: Advertise budget (minimum 10 days prior to public hearing)
- August 11, 2010: Advertise budget (minimum 3 days prior to public hearing)
- August 16, 2010: Adoption of Salary Ordinances and Public Hearing of City Budget

- September 15, 2010: Proposed City Budgets to the County Council
