CONSENT AGENDA

Mr. Eggers, seconded by Mr. Barrow, made a motion to approve the consent agenda as presented.

The motion carried and the consent agenda was approved.

Due to the procedural requirement in the Indiana Code, Mayor Jones-Matthews requested that Resolution 07-03: A Resolution Adopting a Fiscal Plan of Services for the Annexation of Certain Territory, be considered prior to the discussion about the Johnson County Animal Shelter annexation ordinance.

NEW BUSINESS

Introduction of Resolution 07-03: A Resolution Adopting a Fiscal Plan of Services for the Annexation of Certain Territory (to be known as the Johnson County Animal Shelter Annexation)

The Planning Director, Joe Csikos, presented the proposed resolution adopting a fiscal plan of services for the annexation of certain territory. A motion and second were made to read by title only. The motion carried and the ordinance was read by title only. Mr. Barrow, seconded by Mrs. Gordon, made a motion to approve Resolution 07-03. The motion carried and the ordinance was approved and signed. Mr. Eggers recused himself and abstained from voting.

OLD BUSINESS

Ordinance 07-01: An Ordinance Approving a Resolution of the City of Franklin, Indiana Plan Commission and Annexing Certain Property Contiguous to the Franklin Corporate Limits (to be known as the Johnson County Animal Shelter Annexation)

The Planning Director, Joe Csikos, presented the ordinance approving a resolution annexing the property located at Commerce Drive and Graham Road into the Franklin Corporate Limits. A motion and a second were made to read by title only. The motion carried and the ordinance was read by title only. Dr. Murphy, seconded by Mr. Barrow, made a motion to approve Ordinance 07-01. The motion carried and the ordinance was approved and signed. Mr. Eggers recused himself and abstained from voting.

PUBLIC HEARING

Budgetary Ordinance No. 07-02: A Common Council budgetary Ordinance Requesting an Additional Appropriation

The Street Commissioner, Richard Hughes, presented the proposed budgetary ordinance requesting \$40,000 to purchase a back hoe. The City has advertised the additional appropriation of \$40,000. Mr. Hughes provided four quotes for used backhoes:

One person asked about the maintenance records of the used equipment under consideration. A motion and second were made to read by title only. The motion carried and the ordinance was read by title only. Mr. Ault, seconded by Dr. Murphy, made a motion to approve Budgetary Ordinance 07-02. The motion carried and the ordinance was approved and signed. Mayor Jones-Matthews requested that Street Department Superintendent Hughes return with the maintenance records and purchase agreements.

NEW BUSINESS

Introduction of Ordinance 07-03: An Ordinance Approving Resolution 07-02 of the City of Franklin, Indiana Plan Commission, Revising Article 3, Chapters 11-13, and Article 13, Chapter 2 of the Franklin City Zoning Ordinance

The Planning Director, Joe Csikos, presented the proposed ordinance revising Article 3, Chapters 11-13, and Article 13, Chapter 2 of the Franklin City Zoning Ordinance. The proposed ordinance will update two sections of the City of Franklin Zoning Ordinance providing an exemption in the Residential Traditional (RT) 1, 2, and 3 zones and add some definitions for the Adult Uses to the definition section of the Ordinance. This ordinance is scheduled for public hearing on May 14, 2007.

Introduction of Ordinance 07-04: An Ordinance Approving Resolution 07-03 of the City of Franklin, Indiana Plan Commission, Rezoning Certain Property to Industrial Business Development (IBD) – To be known as the RSW Development Rezoning

The Planning Director, Joe Csikos, presented the proposed ordinance rezoning certain property to industrial business development to be known as the RSW Development Rezoning. Mr. Csikos stated that the Plan Commission forwarded this ordinance to the Council with a unanimous favorable recommendation. A discussion was held.
