RESOLUTION NUMBER 2012-20

APPROPRIATION RESOLUTION OF THE CITY OF FRANKLIN REDEVELOPMENT COMMISSION

WHEREAS, the City of Franklin Redevelopment Commission (the "Commission"), as the governing body for the City of Franklin Redevelopment Department (the "Department"), pursuant to Indiana Code 36-7-14, determines that it is in the best interest of the City of Franklin, Indiana, and the Redevelopment District to create a Redevelopment District Capital Expense Fund; and

WHEREAS, the Commission finds that there are insufficient funds available or provided for in the existing budget and tax levy to fund expenses associated for the purpose of paying fees and expenses related to obtaining appraisals on the real property commonly known as the GC Murphy building, located at 56/58 East Jefferson Street, Franklin, IN 46131, and

WHEREAS, notice of a hearing on said appropriation has been duly given by publication and posting as required by law, and the hearing on said appropriation has been held, at which all taxpayers had an opportunity to appear and express their views as to such appropriation.

NOW, THEREFORE, BE IT RESOLVED by the City of Franklin Redevelopment Commission, that:

- Section 1. <u>Additional Appropriation</u>. There is hereby appropriated for the purpose of paying fees and expenses related to obtaining appraisals on the real property commonly known as the GC Murphy building, located at 56/58 East Jefferson Street, Franklin, IN 46131, and related expenses of the Commission, a sum not to exceed Ten Thousand Dollars (\$10,000) of from the capital expense fund. Such appropriation shall be in addition to all appropriations provided for in the existing budget and shall continue in effect until the completion of the described purposes.
- Section 2. <u>Miscellaneous</u>. The Clerk-Treasurer is directed to pay for the said expenses from invoices generated from selected vendors and others as applicable in the amounts that do not exceed the total appropriation. The President of the Commission, the Secretary of the Commission, the Clerk-Treasurer of the City and any other appropriate officers of the Commission and the City are hereby authorized to take all such actions and execute all such instruments as are necessary or desirable to effectuate this Resolution, including the filing of a report of this appropriation with the Indiana Department of Local Government Finance.
- Section 3. <u>Effective Date</u>. This resolution shall be in full force and effect from and after its adoption.
