## Board of Public Works and Safety Regular Meeting Minutes October 21, 2013

The regular meeting of the Board of Public Works and Safety of the City of Franklin, Indiana was called to order at 5:00 p.m. at City Hall, 70 E. Monroe Street, with Mayor Joseph E. McGuinness presiding. Board member Stephen Barnett answered roll call. Board member Bob Swinehamer was absent.

Police Lieutenant Kerry Atwood, Fire Chief John Henderson, Parks Department Superintendent Chip Orner, Sewer Billing Office Manager Sherry Phillips, DPW Superintendent Rick Littleton, Community Development Director Krista Linke, City Engineer Travis Underhill, Interim Street Commissioner Andrew Duckworth, Clerk Treasurer Janet Alexander, Clerk-Treasurer Assistant Kristi Bruther, and City Attorney Lynnette Gray were also in attendance.

Mayor McGuinness led the Pledge of Allegiance.

### **Announcements & Presentations**

### Ray's Trash Report

Britter Matthews-Cook appeared before the Board to report on the 2<sup>nd</sup> and 3<sup>rd</sup> quarter collection rates for 2013. She commented that the recycling for 2<sup>nd</sup> and 3<sup>rd</sup> quarter were the same at 8.74%. Ms. Matthews-Cook offered an apology to Mr. Swinehamer and to the Board regarding a reported gesture made by an employee and stated that it has been addressed. Ms. Matthews-Cook also stated that the issue of blocking the roadways has been addressed with the drivers.

### **Public Comments**

### Lack of Enforcement and Status of Three-Hour Parking Limits Downtown

Downtown business owner Eric Fredbeck appeared before the Board to discuss the three-hour minimum parking restrictions in the downtown area. Mayor McGuinness stated that he has heard similar concerns from others and has also had conversations with County Commissioner Baird. Mayor McGuinness explained that the current ordinance did match the signs that had been posted; therefore, he stated that it is time to review the existing ordinance and to post accurate signage.

#### **Martin Place**

Resident Eric Rose appeared before the Board to request barricades for Martin Place on Halloween. Mayor McGuinness, seconded by Mr. Barnett, made a motion to approve the street barricades on October 31, 2013 from 5:30 p.m. to 9:30 p.m. A voice vote was taken with all members stating aye. The motion carried.

## Request Approval to Remove "No Parking" sign in front of 1179 Stellar Drive - Tabled from previous meeting

Resident Brooke Lawson appeared before the Board to request the removal of a "no parking" sign on 1179 Stellar Drive. Discussion held. Mayor McGuinness, seconded by Mr. Barnett, made a motion to remove the sign. A voice vote was taken with all members stating aye. The motion carried.

## Recommendation and Contract for Knollwood Farms Drainage Improvements

City Engineer Underhill stated that he reviewed the bid documents opened at the last meeting and recommended Dave O'Mara Contractor, Inc. for the Knollwood Farms Drainage Improvement project. He stated that the base bid was both, responsive and the lowest bid. Mayor McGuinness, seconded by Mr. Barnett, made a motion to approve the base bid contract with Dave O'Mara Contractor, Inc. A voice vote was taken with all members stating aye. The motion carried.

## **Department Reports / Staff Reports**
