**A RESOLUTION WAIVING NON-COMPLIANCE
WITH RESPECT TO REXAM CONSUMER PLASTICS INC.'S
TAX ABATEMENT COMPLIANCE REQUIREMENTS**

Whereas, the Common Council of the City of Franklin, Indiana granted a ten-year tax abatement to Rexam Consumer Plastics, Inc. relative to the installation and use of certain personal property improvements through Resolution 2010-05, Resolution 2010-06 and Resolution 2012-08;

Whereas, due to a clerical error, Rexam Consumer Plastics, Inc., failed to properly account for the deductions to which they were entitled.

Whereas, pursuant to Indiana Code Section 6-1.1-12.1-9.5, the Common Council of the City of Franklin, Indiana find that this non-compliance should be waived.

NOW, THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, THAT:

- 1) **Waiver of Non-Compliance.** Rexam Consumer Plastics Inc.'s non-compliance with the filing requirements of its tax abatement, as referenced above, is waived.
- 2) **Effective Date.** This Resolution shall be in full force and effect from and after its passage and as provided by for applicable law.
