

**RESOLUTION NUMBER 2014-02**

**APPROPRIATION RESOLUTION OF THE  
CITY OF FRANKLIN REDEVELOPMENT COMMISSION**

**2014 Legal and Financial Fees**

**WHEREAS**, the City of Franklin Redevelopment Commission (the "Commission"), as the governing body for the City of Franklin Redevelopment Department (the "Department"), pursuant to Indiana Code 36-7-14, as amended (the "Act"), has previously designated an area known as the Amended Integrated Economic Development Area (the "Economic Development Area"), as an economic development area pursuant to Section 41 of the Act,

**WHEREAS**, the Commission designated a portion of such Economic Development Area as allocation areas (the "Allocation Areas") pursuant to Section 39 of the Act; and

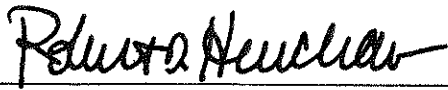
**WHEREAS**, the Commission finds that there are insufficient funds available or provided for in the existing budget and tax levy to fund legal and financial fees and expenses for 2014 projects within the Amended Integrated Economic Development Areas, plus the administrative expenses for same; and

**WHEREAS**, notice of a hearing on said appropriation has been duly given by publication and posting as required by law, and the hearing on said appropriation has been held, at which all taxpayers had an opportunity to appear and express their views as to such appropriation.

**NOW, THEREFORE, BE IT RESOLVED** by the City of Franklin Redevelopment Commission, that:

1. Additional Appropriation. There is hereby appropriated for the purpose of paying the expenses associated with the project provided by Schafstall and Admire, LLP and other legal or financial services providers, and related expenses of the Commission, a sum not to exceed Fifty Thousand Dollars (\$50,000.00) of tax increment revenues collected from the T.I.F. Areas within the Economic Development Area, to be paid pro rata from each individual Allocation Area. Such appropriation shall be in addition to all appropriations provided for in the existing budget and shall continue in effect until the completion of the described purposes.
2. Miscellaneous. The Clerk-Treasurer is directed to pay for the said expenses from invoices generated from Schafstall and Admire, LLP and others as applicable in the amounts that do not exceed the total appropriation. The President of the Commission, the Secretary of the Commission, the Clerk-Treasurer of the City and any other appropriate officers of the Commission and the City are hereby authorized to take all such actions and execute all such instruments as are necessary or desirable to effectuate this Resolution, including the filing of a report of this appropriation with the Indiana Department of Local Government Finance.
3. Effective Date. This resolution shall be in full force and effect from and after its adoption.

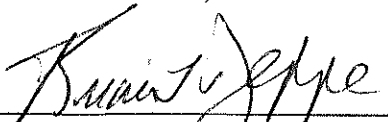

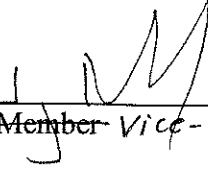

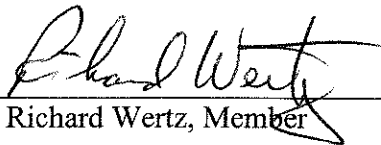
