**ORDINANCE NUMBER 14-09  
OF THE CITY OF FRANKLIN, INDIANA**

**AN ORDINANCE CREATING AND AUTHORIZING  
THE USE OF A IHCD A HOUSING GRANT FUND**

**Whereas**, the Clerk-Treasurer of the City of Franklin, Indiana has determined and the Common Council of the City of Franklin, Indiana concurs that the City does not have an appropriate fund account to maintain and administer monies received pursuant to IC 36-1-3-6 for the IHCD A Housing Grant.

**Whereas**, the Common Council authorized the application of the IHCD A Housing Grant via Common Council Resolution 13-17, adopted June 17<sup>th</sup>, 2013.

**Now**, Therefore, the Common Council of The City of Franklin, Indiana, Ordains and Enacts the following:

- 1) **Creation of the "IHCD A Housing Grant Fund"**. A new fund account, to be referred to as the "IHCD A Housing Grant Fund", and which is to be given a number or letter designation by the Clerk as she deems appropriate, is created for use by the City.
- 2) **Authorized Use of the IHCD A Housing Grant Fund**: The Fund will segregate and account for grant funds received and community contributions required by the grant. Accounts maintained in the Fund are to be segregated as needed for appropriate administration. The IHCD A Housing Grant Fund is non-reverting, i.e., balances will not be transferred into other funds, such as the General Fund, Local Road and Street, or Motor Vehicle / Highway, and all monies deposited in the CDBG Façade Grant Fund may only be used for the purpose agreed upon by the Common Council.
- 3) **Construction of Clause Headings**. The clause headings appearing in this ordinance have been provided for convenience and reference, and do not purport and will not be deemed to define, limit, or extend the scope or intent of the clauses to which the headings pertain.
- 4) **Repeal of Conflicting Ordinances**. The provisions of all other ordinances in conflict with the provisions of this ordinance are of no further force or effect, and are now repealed.
- 5) **Severability of Provisions**. If any part of this ordinance is held to be invalid, such part will be deemed severable and its invalidity will have no effect upon the remaining provisions of this ordinance.
- 6) **Duration and Effective Date**. The provisions set forth in this ordinance become and will remain in full force and effect (until their repeal by ordinance) on day of the passage and adoption of this ordinance by signature of the executive in the manner prescribed by Indiana Code § 36-4-6-15, 16.
