#### PC 2014-06 (A): Custer Baker Annexation:

He stated part of the property is zoned Institutional and part is zoned Residential: Rural. He stated that the school is not currently requesting the property be rezoned. He stated that they understand that if there is future development of the residentially zoned parcel that they may need to request a rezoning or obtain approval from the Board of Zoning Appeals. There is no request for rezoning at this time.

Staff recommends a favorable recommendation be forwarded to City Council.
