3. Consent Agenda

a. Approval of meeting minutes from June 19, 2014

b. Approval of June Claims

c. Approval of Human Resources Report

4. Old Business

- a. Greenway Trail extension to Paris Estates update
 - 1. Schedule special board meeting to open quotes for trail extension. Meeting was set by Chip Orner to meet Thursday, July 31, 2014 at 3:00 pm for quote openings. Chip informed the Board that the engineering and design work would be accomplished this week and Crossroads Engineering would be securing 4 quotes. Chip also notified the Board that in the space for the trail there is a large tree that will need to come down. It has previously been trimmed many times by utility companies.
 - 2. Chip presented the Board with a Order of Payment of Appraisers in the amount of \$5,775.00 to be paid to the Clerk of Johnson County Court for the Upper Shelbyville Trail extension. A motion was made by Dr. John Shafer and seconded by Debbie Gill to approve payment of the Appraisers fees pending the review of the fees by Park Board Attorney, J. Andrew Woods. The Board unanimously approved.

b. 2015 Budget Update

Chip informed the Board the budget committee had met. The committee is awaiting instructions from Mayor McGuinness who is awaiting the 6 month budget reports from the Clerk Treasurers Office. The Council begins Budget talks their second meeting in August. Chip and Rocky are working on prioritizing the proposed list of needs for the 2015 Parks Budget.

c. Family Aquatic Center update

Chip informed the Board that the Aquatic Center, in spite of a rainy season, is doing well and is on track to make over \$300,000 for the 2014 season.

5. **New Business**

a. Staffing

There was a discussion held regarding the need to do some restructuring for two departmental positions. With the extreme success of the Franklin Family Aquatic Center and its need for more time dedicated to it and the decline in the indoor Aquatic Programs, it was suggested that a full time Aquatics director be hired to lead both areas. The Active Adult Center leadership would be reduced to a part time position with doors continuing to be open Monday through Friday from 9 am to 3 pm.

A motion was made by Dr. John Shafer and seconded by Debbie Gill to pursue a full time Aquatics Director position and changing to a part time Active Adult Center Manager position. The Board unanimously approved.
