# City of Franklin Common Council Regular Meeting Minutes December 15, 2014

The regular meeting of the Common Council of the City of Franklin, Indiana was called to order at 6:00 p.m. at City Hall, 70 E. Monroe Street, with Mayor Joseph E. McGuinness presiding. Mayor McGuinness opened the meeting and asked the Clerk-Treasurer to call the roll. Project), and to Loan the Proceeds Thereof to the Franklin United Methodist Home, Inc. and Authorizing and Approving Other Actions In Respect Thereto - Mayor McGuinness read by title only. Mr. Richard Starkey, representative from Barnes and Thornburg, appeared before the Council. He explained that there is no monetary obligation to the City. Councilor Austin stated that the Planning Commission made a favorable recommendation. Mayor McGuinness opened the floor for public comments. No one from the public asked to speak. The public comments were closed. Council President Barnett made a motion to approve, seconded by Councilor Abban. A voice vote was taken with all members stating aye. The motion carried.

Common Council Budgetary Ordinance No.: 14-17 A Budgetary Ordinance Authorizing an Additional Appropriation for Parks 200 Supplies in the amount of \$3,000.00 & Parks 300 Services in the amount of \$27,000.00 - Mayor McGuinness read by title only. Parks Superintendent Orner appeared to answer questions. Mayor McGuinness opened the floor for public comments. No one from

Ms. Linke explained that the Greenwood Mayor approached her in regard to applying for this grant as a community grant. There is no match required. The grant if funded would include four sites for Greenwood, two for Whiteland and two for Franklin. Council President Barnett made a motion to approve, seconded by Councilor Abban. A voice vote was taken with all members stating aye. The motion carried.
