**BUDGETARY ORDINANCE No.: 15-11 AN ADDITIONAL APPROPRIATION  
ORDINANCE**

WHEREAS, it has been determined that it is now necessary to appropriate money from the Riverboat fund in the amount of \$400,000.00 and the Disaster Relief Fund in the amount of \$1,000,000.00 for the 2015 Paving Program.


