**A RESOLUTION WAIVING NON-COMPLIANCE

TAX ABATEMENT COMPLIANCE REQUIREMENTS**

Whereas, the Common Council of the City of Franklin, Indiana granted a seven year real property tax abatement to JM Stevens Enterprises LLC through Resolution 2013-03;

Whereas, due to a clerical error, JM Stevens Enterprises LLC, failed to turn in their first yearly compliance report in a timely manner for the tax year 2014 payable 2015.

Whereas, pursuant to Indiana Code Section 6-1.1-12.1-9.5, the Common Council of the City of Franklin, Indiana find that this non-compliance should be waived.

**NOW, THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, THAT:**

- 1) **Waiver of Non-Compliance.** JM Stevens Enterprises LLC non-compliance with the filing requirements of its tax abatement, as referenced above, is waived.
- 2) **Effective Date.** This Resolution shall be in full force and effect from and after its passage and as provided by for applicable law.
