**RESOLUTION NO. 15-20**

**A RESOLUTION OF THE COMMON COUNCIL OF THE  
CITY OF FRANKLIN, INDIANA, AUTHORIZING AN EXTENSION OF THE 2015  
LOAN FROM THE RAINY DAY FUND TO THE FLOODED-PROPERTIES  
ACQUISITION PROJECT**

**WHEREAS**, the Common Council of the City of Franklin, Indiana (the "Council") on January 5, 2015, approved Resolution 15-01 authorizing a temporary loan of \$125,000 from the Rainy Day Fund to the CDBG Flood Buy Out Grant Fund in order to complete the buyout of properties damaged in the June 7, 2008 flood, and;

**WHEREAS**, the Common Council of the City of Franklin, Indiana has learned that the IHCD is unable to reimburse the City's portion of the grant by the end of calendar year 2015; a circumstance which is beyond the city's control, thereby creating an emergency requiring the Council to consider an extension of the temporary loan from the Rainy Day Fund to the CDBG Flood Buy-Out Grant Fund.

**WHEREAS**, such a loan should be repaid no later than June 30 2016; and

**WHEREAS**, Indiana Code §36-1-8-4-b, authorizes the extension of a temporary loan,

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
FRANKLIN, JOHNSON COUNTY, INDIANA, THAT:**

Section 1. The Common Council authorizes an extension of the One Hundred and Twenty-Five Thousand Dollars (\$125,000.00) temporary loan from the City's Rainy Day Fund to the CDBG Flood Buy Out Grant Fund for use as working capital in the Acquisition Project.

Section 2. The loan must be repaid not later than June 30, 2016 to the City's Rainy Day Fund.

Section 3. This Resolution shall be in full force and effect from and after its passage and approval by the Council.
