RESOLUTION OF THE FRANKLIN COMMON COUNCIL AUTHORIZING THE SUBMITTAL OF THE RAILROAD SAFETY IMPROVEMENTS APPLICATION TO THE INDIANAPOLIS METROPOLITAN PLANNING ORGANIZATION AND ADDRESSING RELATED MATTERS

WHEREAS, the City of Franklin, Indiana, Johnson County, the City of Greenwood, the Town of Whiteland and the Louisville and Indiana Railroad have tentatively agreed to share the cost of matching funds for such safety improvements.
