RESOLUTION NO. 2015-23**

**A RESOLUTION WAIVING NON-COMPLIANCE WITH
TAX ABATEMENT COMPLIANCE REQUIREMENTS BY
JM STEVENS ENTERPRISES, LLC**

WHEREAS, the Common Council of the City of Franklin, Indiana (the "Council") granted a seven (7) year tax abatement on real property to JM Stevens Enterprises, LLC through Resolution 2013-03;

WHEREAS, due to a clerical error, JM Stevens Enterprises, LLC failed to timely file Form 322 ("Application for Deduction from Assessed Valuation of Structures in Economic Development Areas") with the Auditor of Johnson County, Indiana; and

WHEREAS, pursuant to Indiana Code Section 6-1.1-12.1-11.3(a)(5), the Council finds that this non-compliance should be waived.

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of Franklin, Indiana, as follows:


1. Waiver of Non-Compliance: JM Stevens Enterprises, LLC's non-compliance with its tax abatement filing requirements should be waived.
2. Effective Date: This Resolution shall be in full force and effect from and after its passage by the Council and approval by the Mayor as required by law.




