

RESOLUTION NO.: 16-04
OF THE COMMON COUNCIL OF THE
CITY OF FRANKLIN, INDIANA

A RESOLUTION AUTHORIZING THE USE OF
Speedway SuperAmerica Credit Cards
(And Repealing Resolution No. 10-18)

WHEREAS, the City of Franklin, Indiana ("City"), by its various departments, require credit accounts and credit card services to assist in the efficient operation of City functions;

WHEREAS, the below named departments have existing Speedway SuperAmerica credit cards, which in order to comply with state regulations, require authorization by the Common Council;

WHEREAS, The former enabling Resolution is repealed in its entirety. The effect of this enactment and repeal is to add an additional credit card line for the Fire Department and upping the limits for both to \$2,500.00, and to add 3 additional cards for the Police Department and upping their limits to \$750.00 each.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, RESOLVES: The Police Department is hereby authorized to maintain and use their existing Speedway SuperAmerica credit card accounts with corresponding credit limits as shown. The below referenced departments collectively are authorized to apply for and utilize Speedway SuperAmerica credit card(s) with a credit line in the amount listed for commercial and business use. Further, the City is authorized and empowered to pay all indebtedness incurred by the use of such credit accounts and credit cards, whether such use is authorized or unauthorized, and that the authority granted by this resolution will apply with equal force and effect to the successors in office to the departments herein named.

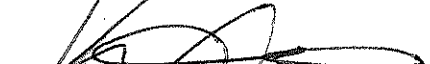

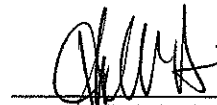
