ORDINANCE NUMBER 16-12 OF THE CITY OF FRANKLIN, INDIANA

AN ORDINANCE CREATING A LOCAL ROAD AND BRIDGE MATCHING GRANT FUND

Whereas, the Common Council of the City of Franklin, Indiana, pursuant to HEA 1001-2016, establishes the Local Road and Bridge Matching Grant Fund to be governed by the applicable statutory provisions provided therein.

Now, Therefore, the Common Council of the City of Franklin, Indiana, Ordains and Enacts the Following:

- 1) Creation of the Local Road and Bridge Matching Grant Fund. A new non-reverting fund to be known as the Local Road and Bridge Matching Grant Fund ("Fund"), and which is to be given number 258, is now established. The Fund shall receive monies from the Local Road and Bridge Matching Grant Fund thru INDOT as well as local match funds transferred from the LOIT Special Distribution Fund.
- 2) Construction of Clause Headings. The clause headings appearing in this ordinance have been provided for convenience and reference, and do not purport and will not be deemed to define, limit, or extend the scope or intent of the clauses to which the headings pertain.
- 3) Repeal of Conflicting Ordinances. The provisions of all other ordinances in conflict with the provisions of this ordinance are of no further force or effect, and are now repealed.
- 4) Severability of Provisions. If any part of this ordinance is held to be invalid, such part will be deemed severable and its invalidity will have no effect upon the remaining provisions of this ordinance.
- Duration and Effective Date. The provisions set forth in this ordinance become and will remain in full force and effect (until their repeal by ordinance) on day of the passage and adoption of this ordinance by signature of the executive in the manner prescribed by Indiana Code § 36-4-6-15, 16.
