Board of Public Works and Safety Regular Meeting Minutes November 21, 2016

The regular meeting of the Board of Public Works and Safety of the City of Franklin, Indiana was called to order at 5:00 p.m. at City Hall, 70 E. Monroe Street, with Mayor Joseph E. McGuinness presiding. Board member Bob Swinehamer answered roll call. Board Member Stephen Barnett was absent.

City Engineer Travis Underhill & Communications Director Krista Linke were absent.

Mayor McGuinness led the Pledge of Allegiance.

Old Business

New Business

Request Approval of Franklin Township Fire Protection Contract - City Attorney Lynn Gray presented the contract for the Franklin Township Fire Protection. The amount was increased from \$50,000.00 to \$60,000.00 for 2016. The contract presented for 2017 is the same as this year. Mr. Swinehamer made a motion to approve, seconded by Mayor McGuinness. A voice vote was taken with all members stating aye. The motion carried.

Request Approval of 2017 Wastewater and Stormwater Utility Operating Budgets - DPW Superintendent Rick Littleton presented the Wastewater and Stormwater Operating Budgets. The presented budgets reflect the salaries adjusted according to the Council's suggestions. Sewer Office Manager Sherry Phillips presented the Sewer Office budget. The presented budget reflects the salaries adjusted. The differences in the budget can be found in the 100 series. The amounts increased and decreased in some line items due to increased costs. The overall budget remained the same. Mr. Swinehamer made a motion to approve as presented, seconded by Mayor McGuinness. A voice vote was taken with all members stating aye. The motion carried.

Request to Transfer 1997 GMC Sierra K2500 from Fire Department to Police Department - Fire Chief Dan McElyea presented this item, and stated they would like to transfer the 1997 GMC Sierra K2500 to the Police Department, as they no longer use it. Mr. Swinehamer made a motion to approve the transfer from the Fire Department to the Police Department, with the Clerk-Treasurer recording the transfer, seconded by Mayor McGuinness. A voice vote was taken with all members stating aye. The motion carried.

Request Approval of 2016 Maintenance Improvement Program: Alley Improvements - Milestone Contractors, LP – Mayor McGuinness stated this request is to encumber the money for the Alley Improvements project which will be completed in the spring of 2017. The most responsive and lowest bidder was Milestone Contractors, LP for \$466,491.68 Mr. Swinehamer made a motion to approve, seconded by Mayor McGuinness. A voice vote was taken with all members stating aye. The motion carried.

2017 Service Contracts between City of Franklin and: (1) Access Johnson County (2) Boys & Girls Club (3) Girl's Inc. (4) Helpline of Johnson County (5) Johnson County Senior Services (6) Discover Downtown Franklin (7) Leadership Johnson County - Mayor McGuinness read the lists of contracts with local service groups, and stated that the contractual

amounts are the same as last year. The funding for these contracts was approved by City Council in the 2017 Board of Public Works budget. Mr. Swinehamer made a motion to approve, seconded by Mayor McGuinness. A voice vote was taken with all members stating aye. The motion carried.

Other Business

There was no other business presented.
